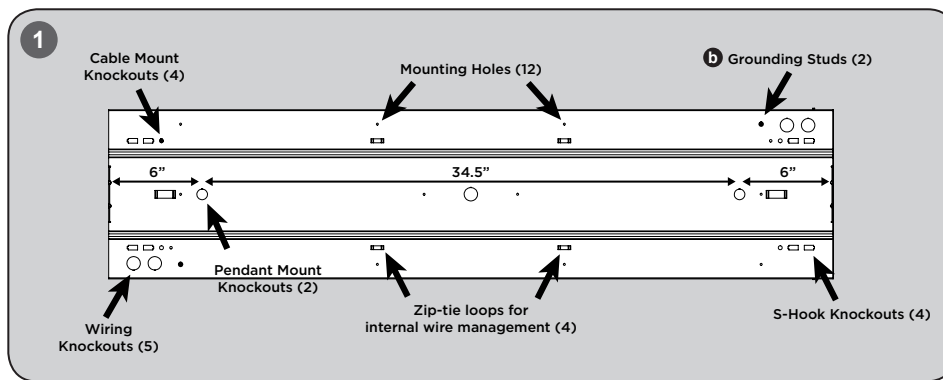
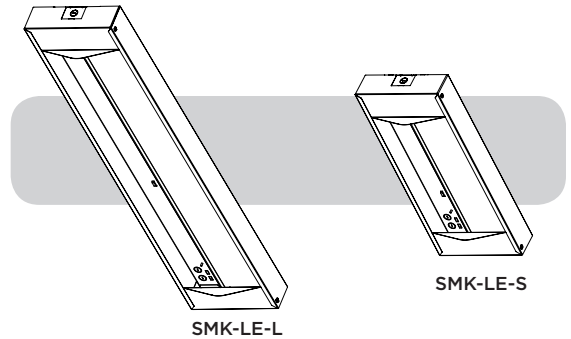
The SMK-LE is designed for use with CR Series Light Engines for surface or suspended mounting.

IMPORTANT SAFETY INFORMATION **Read all instructions before installation**

(1) Before installing this fixture or doing any maintenance, make sure to turn off the power supply at the circuit breaker or fuse box. (2) Do not handle energized module with wet hands or when standing on wet or damp surfaces, or in water.

WARNING - Risk of Electric Shock. Suitable for damp locations. Access above ceiling required. Do not install insulation within 3"(76mm) of any part of the luminaire. Suitable for suspended ceilings.

INSTALL BASE HOUSING ON TO SURFACE OR SUSPEND FROM CHAIN:

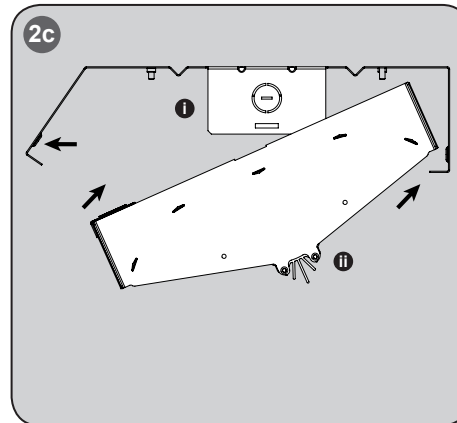
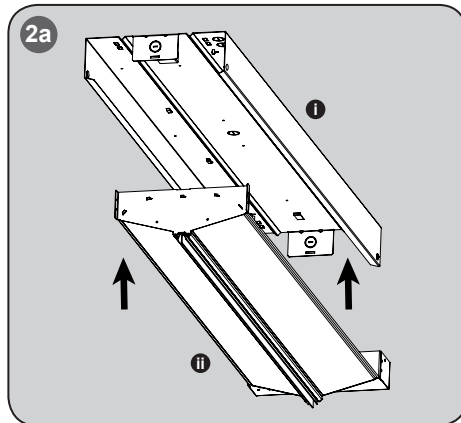
STEP 1a:

See Fig. 1 for all mounting features and wiring access points.

NOTE: Distance between the two Pendant Mount Knockouts for SMK-LE-L is 34.5", and 13.25" for the SMK-LE-S. The distance from each edge of SMK-LE-L and SMK-LE-S and the two Pendant Mount Knockouts is 6".

STEP 1b:

Attach ground wire lead to grounding stud of your choice using included ground nut.



INSTALL CR SERIES LIGHT ENGINE INTO BASE HOUSING:

STEP 2a:

Place one edge of Light Engine (ii) on inside edge of housing (i).

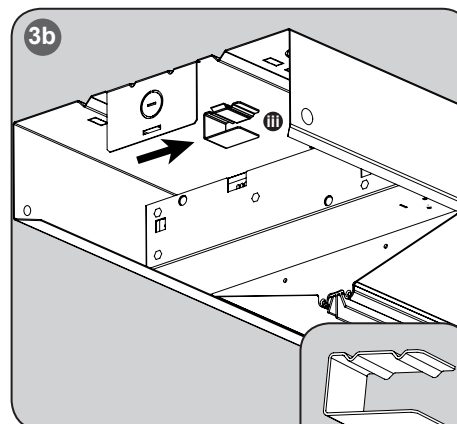
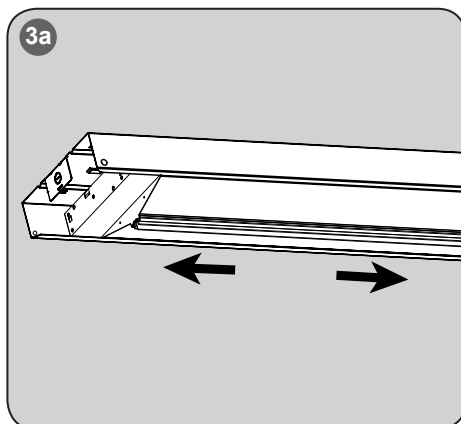
STEP 2b:

Pull housing side wall to outward.

STEP 2c:

Rotate Light Engine into housing.

- Route all AC wires through knockouts and attach to CR Series Light Engine leads as indicated in the installation instructions included with the CR Series Light Engine.
- Dress wires using zip-ties (**not provided**) through loops where indicated above.



INSTALL STAND-OFF BRACKETS AND GROUND WIRE:

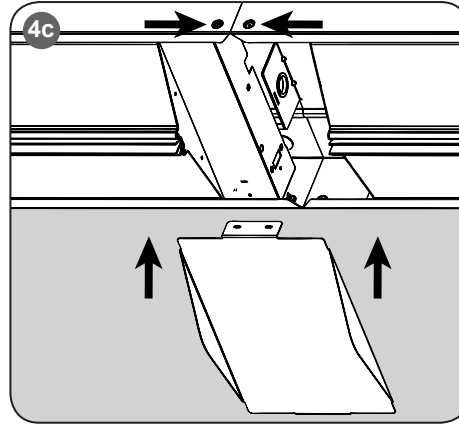
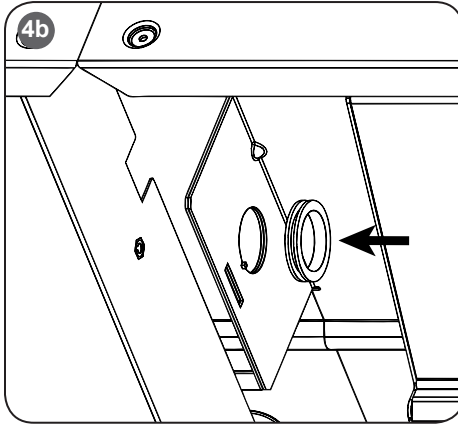
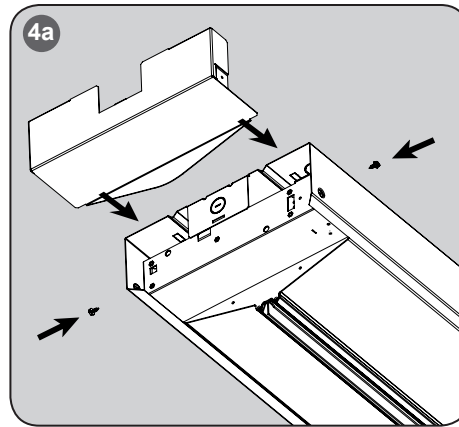
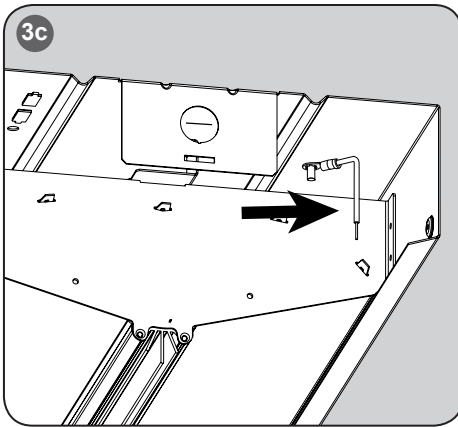
STEP 3a:

Slide the CR Series Light Engine to either end of the housing to expose the stand-off loop.

STEP 3b:

Install stand-off brackets (iii) by sliding the tab

with the detent bumps into the receiving loop.

STEP 3c:

Install ground wire with the (8-32) star nut (provided).

INSTALL END CAPS OR JOINING PLATE:

STEP 4a:

For Joining Plate instructions proceed to **STEP 4b**. Install an End Cap on each end to complete the enclosure and secure with (2) sheet metal screws each.

STEP 4b:

Install the Joining Plate to enclose adjoining units in a series by installing plastic grommet (**included**) through both knock-outs between units.

STEP 4c:

Secure the Joining Plate using (4) sheet metal screws.
